Documents locked in a pending status in ProcureAZ will be unlocked tonight after close of business. As of this morning the following agencies had locked documents (this week all are requisitions):

• If you have the same documents showing up as locked for multiple weeks, it is likely caused by a known defect when list & approve is used instead of approving documents individually on the Summary tab. The fix for this issue will be deployed for testing shortly.

The next **scheduled** evening to unlock documents is Friday, July 1<sup>st</sup>. If significant system performance issues occur prior to that date the process will be run sooner.
